- 4. STATE CORPORATE TAX Your state recognizes the federal Letter of Determination and does not require any additional state filings in order to be income tax-exempt for state purposes.
- 5. STATE SALES TAX EXEMPTION States usually offer sales tax exemption for nonprofit organizations or they offer no such exemption. Your state has a variation and has very limited or specific protocols to grant sales tax exemption. For further information, please contact your state office.

The organization could have additional state and federal filing requirements. This would depend on the type of organization and other factors such as: product sales, employees and independent contractors.
